November 2, 2023
Minutes (Proposed)**

Call to Order: 7:04 pm.

Attendance and Approval of Minutes: Meeting sign-in sheet confirms seven (7) attendees. Per the PAWS bylaws a quorum consists of nine (9) member households. Wrapped up football season and did well with concessions. Bylaws have been reviewed and updated and will be voted on at the February meeting as they cannot be voted on tonight.

Regular newsletters are going out to the full list of WWS families as Freshman families were recently added, and membership is at 441 families right now, up from 393 last year. Vice President of Ways & Means' Report - Maureen reported for Mike Harbert

We have begun changes to the PAWS grant process which will be in the new bylaws. We are looking to go back to the process from a few years ago with grants distributed in the Fall and Spring of the school year. We are also working on wrapping up the grants from Spring 2023.

Treasurer Report - Report reported for Chris Preede

For Fall concessions the only outstanding expense is Wheaton Meat which is \$1400. Net of this expense, fall concessions is \$27,200 which is 210% more than last year. We had 5 games plus TigerFest this year compared to 3 games last year. Tim and Janelle and team deserve a giant thank you for all their leadership, planning and hours spent on game day prepping and serving food. Reserved Football Parking: About 2x the amount raised last year. Thanks to Mike for arriving at every game early to set up and managing the game day parking fee collection. PE Uniform check from Wheaton Sport Center was received, about 10% lower than the total for last year.

Principal's Report - Lori Campos

A question was raised regarding the process for or opportunity for a brick being provided for alumni, specifically in the honor of a former student that passed away after graduation. PAWS does coordinate the purchasing and installation of the bricks along Tradition Trail for retirees and certain Tiger board members. Will have Mike Healy contact Maureen or Jen to discuss. Some recent discriminatory incidents with very few kids and the newsletter was to address this situation. Has been a mixture of grade level and targeted at individuals and groups of individuals. A restorative session was held with the individuals and those outcomes were positive. We've also, over the past few days, had about 20 kids shadowed by staff members for four (4) periods and will debrief with kids tomorrow during lunch and with staff on Monday. We are surveying the staff every afternoon and just surveyed staff again and those scores were very high with the staff feeling that they are valued. Continuing with "Cookies with Campos. Invitation to six kids and they can bring a friend and students have been communicating things feel happier this year. Cross county boys & girls at state this week. Swim & dive at sectionals this weekend. Freshman thankful tree was put up this week and the freshman filled the "leaves" with what they are thankful for at South. Instagram updates are ongoing. There is the principal Instagram which is focused on extracurricular and the WWSHS Instagram which provides classroom updates. AP Spanish Day of the Dead is in the art cases down the art hallway. Also been hosting "Coffee with Campos". Invitation goes to 25 students and their parents each month. Right now getting about 5 each time, meetings are in the mornings around 8:00. Potential to increase the invite list for more students/parents to attend.
